IN CONSIDERATION OF THE EXTENSION OF CREDIT BY F & F HARDWARE AND SUPPLY, INC. THE UNDERSIGNED CUSTOMER COVENANTS AND AGREES TO THE FOLLOWING TERMS AND CONDITIONS:

1. ALL CHARGES FOR CREDIT PURCHASES WILL BE PAID IN FULL BY CUSTOMER WITHIN THE STATED TERMS.
2. CUSTOMER AGREES TO PAY A SERVICE CHARGE OF 1.5% PER MONTH (18% ANNUAL PERCENTAGE RATE) ON THE OUTSTANDING BALANCE OF ACCOUNTS DUE FOR MORE THAN 30 DAYS.
3. CUSTOMER WILL BE PERSONALLY LIABLE FOR ALL DEBTS INCURRED TO F & F HARDWARE AND SUPPLY, INC.
4. IF F & F HARDWARE AND SUPPLY, INC. RETAINS COUNSEL FOR THE PURPOSE OF COLLECTING ANY MONIES WHICH MAY BE UNDER THIS CREDIT AGREEMENT, THEN IN THAT EVENT THE CUSTOMER AGREES TO PAY REASONABLE ATTORNY'S FEE, TOGETHER WITH ANY DISBURSEMENTS AND CURT COSTS IN CONNECTION WITH THE COLLECTION. THE COUNSEL FEES AND DISBURSEMENTS ARE IN NO EVENT TO AFFECT, BUT ARE TO BE PAID IN ADDITION TO STATUTORY COURT COSTS AND DISBURSEMENTS.
5. CUSTOMER HEREBY AGREES AND DESIGNATES BRONX COUNTY, STATE OF NEW YORK FOR VENUE AND JURISDICTION OF ALL LAWSUITS TO ENFORCE THE COLLECTION OF THE ACCOUNT. CUSTOMER FURTHER WAIVES THE RIGHT TO A JURY TRIAL IN ANY ACTION OF PROCEEDING BETWEEN THE PARTIES.
6. THE TERMS OF THIS AGREEMENT SHALL BE DETERMINED BY LAWS OF THE STATE OF NEW YORK.
7. APPLICANT HEREBY ALLOWS F & F HARDWARE AND SUPPLY, INC. AND / OR ITS AGENT TO GENERATE A CREDIT PROFILE FOR PURPOSES OF EXTENDING CREDIT TO APPLICANT.
